**TELANGANA ACTS, ORDINANCES AND

The following Act of the Telangana Legislature received the assent of the Governor on the 27th January, 2017 and the said assent is hereby first published on the 31st January, 2017 in the Telangana Gazette for general information:-

ACT No. 15 OF 2017.

**AN ACT FURTHER TO AMEND SRI VENKATESWARA
 VETERINARY UNIVERSITY ACT, 2005**

Be it enacted by the Telangana Legislature in the Sixty-seventh Year of the Republic of India as follows:-

1. (1) This Act may be called Sri Venkateswara Veterinary University (Amendment) Act, 2016;

(2) It shall be deemed to have come into force with effect from the 29th September, 2014.

2. In Sri Venkateswara Veterinary University Act, 2005 (hereinafter referred to as the principal Act), in section1,-

(a) in sub-section (1) and throughout the Act, for the expression "Sri Venkateswara Veterinary University" wherever it occurs the expression "P.V. Narsimha Rao Telangana Veterinary University" shall be substituted; and there shall also be made in any sentence in which the expression occurs such consequential amendments as the rules of grammar may require;

(b) after sub-section (4), the following sub-section shall be added, namely,-

"(5) (1) Notwithstanding anything contained in Sri Venkateswara Veterinary University Act, 2005 all the colleges and institutions affiliated to Sri Venkateswara Veterinary University and located in Telangana State shall, on and from the appointed date i.e., 22-11-2014 be dis-affiliated from the said University and thereupon they shall be deemed to have been affiliated to the University.

(2) Notwithstanding such dis-affiliation of the colleges under clause (1) from Sri Venkateswara Veterinary University, the University may request Sri Venkateswara Veterinary University for the conduct of the examinations and the declarations of results so far as they relate upto 31-12-2015 and it may also request for necessary action in the interest of students to meet any contingency that might arise, as a result of the dis-affiliation under clause (1)."

3. In section 3 of the principal Act, for sub-section (4), the following shall be substituted, namely:- Amendment of section 3.

“(4) the Headquarters of the University shall be at Rajendranagar, Hyderabad.”

4. In section 21 of the principal Act, in sub-section (1), Amendment of section 21.

(a) for item (b), the following shall be substituted, namely:-

“(b) “the Vice-Chancellors of Kaloji Narayana Rao University of Health Sciences, and Professor Jayashankar Telangana State Agricultural University”;

(b) item (n) shall be omitted.

5. In section 42 of the principal Act, in sub-section (6), for the words “Legislative Assembly”, occurring at two places, the word “Legislature” shall be substituted. Amendment of section 42.

6. In the principal Act, section 46 shall be omitted. Omission of section 46.

7. In the principal Act, for the First and Second Schedules, the following shall be substituted, namely,- Amendment of Schedules.

CHAPTER - I

Preliminary

Short title, extent, commencement and application

1. (1) This Act may be called P.V. Narsimha Rao Telangana Veterinary University Act, 2017.
- (2) It extends to the whole of the State of Telangana.
- (3) It shall come into force with effect from 22.11.2014 (i.e. appointed day).
- (4) (i) It shall apply in the first instance to the Colleges, the Polytechnics, Research Stations and Schemes and Institutions shown in the first and second schedules and other institutions started after the year 2005 and located in the State of Telangana.
- (ii) The Government may, by notification, apply the provisions of this Act to any other college or institution with effect on and from such date as they may specify in this behalf.
- (iii) *With effect on and from the appointed date, all colleges situated in Telangana State and admitted to the privileges of Sri Venkateswara Veterinary University, Tirupati shall be deemed to have been admitted to the privileges of the University."*
- (5) (1) *Notwithstanding anything contained in Sri Venkateswara Veterinary University Act, 2005 all the colleges and institutions affiliated to Sri Venkateswara Veterinary University and located in Telangana State shall, on and from the appointed date i.e., 22.11.2014 be dis-affiliated from the said University and thereupon they shall be deemed to have been affiliated to the University.*
- (2) *Notwithstanding such dis-affiliation of the colleges under sub-section (1) from Sri Venkateswara Veterinary University, the University may request Sri Venkateswara Veterinary University for the conduct of the examinations and the declarations of results so far as they relate upto 31-12-2015 and*

it may also request for necessary action in the interest of students to meet any contingency that might arise, as a result of the dis-affiliation under sub-section (1)".

Definitions

- 2 In this Act, unless the context otherwise requires:-
- (a) "Academic Council" means the Academic Council of the University;
 - (b) "Appointed day" means the date appointed under sub-section (3) of section 1 for the coming into force of this Act;
 - (c) "Authority" means any Authority of the University specified in section 18;
 - (d) "Board" means the Board of Management of the University;
 - (e) "Faculty" means a Faculty of the University;
 - (f) "Government" means the state Government;
 - (g) "Officer" means any Officer of the University specified in section 9;
 - (h) "Prescribed" means prescribed by the statutes or regulations;
 - (i) "Registrar" means the Registrar of the University;
 - (j) "Registered graduate" includes a graduate in veterinary sciences registered under conditions prescribed in this behalf;
 - (k) "Regulations" means the regulations of the University made under this Act;
 - (l) "Statutes" means the statutes of the University made under this Act;
 - (m) "Student" includes a person enrolled in the University for taking a course of study for a degree, diploma or other academic distinction duly instituted, or for undergoing any training;

- (n) "Teacher" includes a Professor, Associate Professor, Assistant Professor, Reader, Lecturer or other person appointed or recognized by the University for the purpose of imparting instruction or conducting and guiding research or extension programmes, and any person declared by the statutes to be a teacher;
- (o) "University" means P.V. Narsimha Rao Telangana Veterinary University constituted under section 3;
- (p) "University College" means a college established or maintained by the University and providing courses of study and qualifying students for admission to the University examinations in accordance with the regulations;
- (q) "Veterinary Sciences" means and include Veterinary, Animal, Avian, Dairy and Fishery Sciences.

Narsimha Rao Telangana Veterinary University which shall consist of a Chancellor, a Vice-Chancellor, a Board of Management and an Academic Council.</p> <p>(2) The University shall be a body corporate having perpetual succession and a common seal and shall sue and be sued by the said name.</p> <p>(3) In all suits and other legal proceedings by or against the University, the pleadings shall be signed and verified by the Registrar and all processes in such suit and proceedings shall be issued to, and served on him.</p> <p>(4) The Headquarters of the University shall be at Rajendranagar, Hyderabad.</p> |
| Objects of the University | 4 | <p>The Objects of University among others shall be to impart education in different branches of Veterinary, Animal and Fishery Sciences; to undertake the extension of such Sciences to the rural people of the State of Telangana; and to promote research, field and extension programmes, production and post-harvest technology including processing and marketing in Veterinary, Animal and Fishery Sciences.</p> |
| University open to all person ¹ | 5 | <p>The University shall, subject to the provisions of this Act and the statutes, be open to all persons; but nothing in this section shall be deemed to require the University to admit to any course of study a larger number of students than may be prescribed:</p> <p>Provided that the Government may reserve seats in Colleges under the University for the members of the Socially and Educationally Backward Classes, the Scheduled Castes and the scheduled Tribes as specified under articles 341 and 342 of the constitution of India in accordance with such principles as may, from time to time be determined by the Government in this behalf.</p> |

Powers and
Functions of the
University

- 6 The University shall have the following powers and functions namely:-
- (a) to provide for instruction, training the research in Veterinary Science;
 - (b) to provide for the advancement and dissemination of knowledge in the files and extension programmes in Veterinary Sciences;
 - (c) to institute courses of study and to hold examinations for, and to confer degrees, diplomas, certificates and other academic distinctions on persons who have pursued a course of study, or carried on research in the University or in an institution recognized in this behalf by the University, as may be prescribed;
 - (d) to confer honorary degrees or other academic distinctions, as may be prescribed;
 - (e) to create teaching, research and extension posts required by the University and to appoint qualified persons to such posts;
 - (f) to institute and award fellowships including traveling fellowships, scholarships, studentships and prizes in accordance with the statutes;
 - (g) to acquire, hold and dispose of property, and to enter into contracts and to do all other things necessary for, or incidental to the objectives of the University;
 - (h) to take over and maintain colleges relating to Veterinary Sciences and hostels thereof;
 - (i) to borrow money from the Government of India, any State Government or any other agency;
 - (j) to establish and maintain the University Colleges and hostels thereof;
 - (k) to fix, demand and receive such fees and other charges as may be prescribed;
 - (l) to provide such lectures and instructions for and to grant such diplomas to field workers, and other persons, as the University may determine;

- (m) to regulate the conduct of students, to maintain discipline among them and to make arrangements for promoting their health and welfare;
- (n) to create administrative, ministerial and other necessary posts and to make appointments thereto;
- (o) to cooperate with other Universities and authorities in such manner and for such purposes, as the University may determine; and
- (p) to do all such acts and things, as may be necessary for the furtherance of the objects of the University.

| The Chancellor | 10 | <p>The Governor of Telangana shall be the Chancellor of the University. He shall, by virtue of his office, be the head of the University, and shall, when present, preside at any convocation of the University. He shall exercise such other powers as may be conferred on him by or under this Act.</p> |
| The Vice-Chancellor | 11 | <p>(1) The Vice-Chancellor shall be a whole time officer and shall be appointed by the Chancellor in the manner prescribed. He shall be paid such salary per mensem as may be prescribed.</p> <p>(2) The Vice-Chancellor shall hold office for a term of three years and shall be eligible for re-appointment for another term of three years.</p> <p>(3) The conditions of service other than the emoluments of the Vice-Chancellor shall be such as may be prescribed and shall not be varied to his disadvantage after his appointment.</p> <p>(4) The Vice-Chancellor may, by writing under his hand addressed to the Chancellor, resign his office. The resignation shall be delivered to the Chancellor ordinarily sixty days prior to the date on which the Vice-Chancellor wishes to be relieved of his office, but the Chancellor may relieve him earlier. The resignation shall take effect from the date of relief.</p> |

- (5) In the temporary absence of the Vice-Chancellor due to leave, or for whatever reason, or until the vacancy caused in any manner is filled, the Chancellor shall appoint any person temporarily to act as Vice-Chancellor.
- (6) Where the post of the Vice-Chancellor falls permanently vacant either by resignation or otherwise, the vacancy shall be filled by the Chancellor in accordance with the provisions of sub-section (1) and the Vice-Chancellor so appointed shall hold office for a full term of three years.
- (7) If, in the opinion of the Chancellor, the Vice-Chancellor willfully omits or refuses to carry out the provisions of this Act or abuses the powers vested in him and if it appears to the Chancellor that the continuance of the Vice-Chancellor in office is detrimental to the interests of the University, the Chancellor may, by order, remove the Vice-Chancellor, after giving him an opportunity of showing cause against the action proposed to be taken in regard to him.

Powers and
duties of the Vice-
Chancellor

- 12 (1) The Vice-Chancellor shall be the academic head and principal executive officer of the university and shall, in the absence of the Chancellor, preside at any convocation of the University.
- (2) It shall be the duty of the Vice-Chancellor to ensure the faithful observance of the provisions of this Act and the statutes and he may exercise such powers as may be necessary for this purpose.
- (3) The Vice-Chancellor shall have power to convene the meeting of the academic council.
- (4) The Vice-Chancellor shall exercise general control over the University and its affairs and shall be responsible for the due maintenance of discipline in the University.
- (5) The Vice-Chancellor shall be responsible for the presentation of the budget and the statement of accounts to the Board.
- (6) Subject to the Control of the Chancellor, in any emergency which, in the opinion of the Vice-Chancellor, requires, immediate action to be taken, he shall take such action as he deems necessary, and shall at the earliest opportunity intimate the action taken to the officer, authority or other body who or which in the ordinary course would have dealt with the matter.

- (7) Where any action taken by the Vice-Chancellor under sub-section (6) affects any person in service of the University to his disadvantage, such person may prefer an appeal to the Board within 30 days from the date on which such person has notice of the action taken.
- (8) The Vice-Chancellor shall give effect to the decisions of the authorities of the University taken in accordance with the powers conferred by or under this Act.
- (9) The Vice-Chancellor shall be responsible for a close co-ordination and integration of teaching, research and extension.
- (10) The Vice-Chancellor shall exercise such other powers as may be prescribed.
- The Registrar 13 (1) The Registrar shall be a whole time officer and shall be appointed by the Board in the manner prescribed.
- (2) The salary and allowances payable to the Registrar and the conditions of service shall be such as may be prescribed:
- Provided that the conditions of service of the Registrar shall not be varied to his disadvantage after his appointment.
- (3) The Registrar shall be responsible for the due custody of the records and the common seal of the University. He shall be ex-officio Secretary of the Board and of the Academic Council, and shall be bound to place before it all such information as may be necessary for the transaction of its business. He shall receive applications for admission into the University and shall keep a permanent record of all courses, curricula and other information as may be necessary.
- (4) The Registrar may, by writing under his hand addressed to the Board, resign his office. The resignation shall be delivered to the Board ordinarily sixty days prior to the date on which the Registrar wishes to be relieved of his office but the Board may relieve him earlier. The resignation shall take effect from the date of relief.

- (5) In the temporary absence of the Registrar due to leave or for whatever reason, or until the vacancy caused in any other manner is filled, the Vice-Chancellor shall appoint any person temporarily for a period not exceeding three months, to act as the Registrar.
- (6) The Registrar shall be responsible for the conduct of the examinations and for the due execution of all processes connected therewith.
- (7) The Registrar shall discharge such other duties and perform such other functions as may be prescribed or required, from time to time, by the Board or the Vice-Chancellor.

- Dean of Student Affairs 16 (1) The Dean of Student Affairs shall be a whole time officer and shall be appointed by the Board in the manner prescribed.
- (2) The salary and allowances payable to the Dean of Students Affairs shall be as may be prescribed.
- (3) The Dean of Student Affairs shall have the following duties namely:-
- (a) to make arrangements for the housing of students;
- (b) to arrange a programme of student counseling;
- (c) to arrange for the employment of students in accordance with the plans approved by the Vice-Chancellor;
- (d) to supervise the extracurricular activities and to look after the needs of student;
- (e) to assist in the placement of graduates of the University; and
- (f) to organize and maintain contact with the alumni of the University.
- Officers not to accept any remuneration from any source other than that provided by statutes 17 No officer shall accept any remuneration from any source other than the remuneration to which he is entitled under the statutes.

CHAPTER - IV***Authorities of the University***

- Authorities of the University 18 The following shall be the Authorities of the University namely
- (i) the Board of Management;
 - (ii) the Academic Council;
 - (iii) the Board of Faculties;
 - (iv) Finance Committee;
 - (v) Planning Board; and
 - (vi) Such other bodies as may be prescribed.
- Constitution of the Board (As per G.O.Ms.9, AH, DD & F (AH) Dept., dt:21.11.2014) 19 (1) The Chancellor shall, as soon as the first Vice-Chancellor is appointed under sub-section (1) of section 11 take action to constitute the Board. The Board of Management shall be constituted in such a manner so that the continuity is ensured.
- (2) The Board shall consists of the following members, namely:-

Ex-Officio Members

- (a) the Vice-Chancellor;
- (b) the Secretary to Government, Animal Husbandry Department;
- (c) the Secretary to Government, Finance Department;
- (d) the Director of Animal Husbandry;
- (e) the Commissioner of Fisheries.

Other Members

- (f) One person to be nominated by the Chancellor from the members of the Indian Council of Agricultural Research;
- (g) One person who is in the opinion of the Chancellor a distinguished Veterinary / Fishery Scientist, nominated by the Chancellor;
- (h) Three persons from the Academic Council to be nominated by the Chancellor;
- (i) Four persons nominated by the Chancellor from among the members of the State Legislature and the members of parliament elected from the State of Telangana.

- (j) Three persons nominated by the Chancellor from amongst the progressive farmers in Livestock, Poultry and Fishery sectors of whom one shall be a woman;
 - (k) One person nominated by the Chancellor from amongst the members of the State Veterinary Council;
 - (l) Two persons nominated by the Chancellor from among the industrialists in Livestock, Poultry and Fishery sectors;
- (3) The Vice-Chancellor shall be ex-officio Chairman of the Board, and shall conduct the meetings of the Board in accordance with the statutes made in that behalf.
- (4) The term of office of Members of the Board other than ex-officio members shall be three years:

Provided that no member of the Board who is nominated shall continue to be a member of the Board on his ceasing to hold the office by virtue of which he has been nominated as member of the Board:

Provided further that even if some of the members are nominated at different times to the Board under items (f) to (l) of sub-section (2), the term of three years in their case shall be reckoned from the date on which the notification constituting the Board was first issued.

- (5) The Members of the Board shall be entitled to receive such daily and traveling allowances as may be prescribed but not to any remuneration.

 - (h) To appoint such committees, either standing or temporary as the Board may consider necessary;
 - (i) to determine and regulate all policies relating to the affairs of the University in accordance with this act and the statutes.
- (2) The Board shall meet at such time and place as it deems necessary but it shall hold a meeting at least once in every two months, and not less than half the number of its meetings in a year shall be held at headquarters of the University.
- (3) The Board may, for purposes of consultation, invite any person having practical experience or special knowledge of any subject under its consideration to attend its meeting. Such person shall have the right to speak in and otherwise to take part in the proceedings of such meeting, but shall not by virtue of this sub section, be entitled to vote at any such meeting. A person attending any such meeting shall be entitled to such allowances as may be prescribed.

 - (j) The establishment and abolition of departments of teaching in the faculties;
 - (k) The establishment and abolition of hostels maintained by the University;
 - (l) The institution of fellowships, scholarships, studentships, bursaries, medals and prizes and the conditions of award thereof;
 - (m) The conditions of registration of graduates and the maintenance of register thereof;

- (n) The admission of students to the University and their enrollment and continuance as such;
- (o) The courses of study to be laid down for all degrees, diplomas and certificates of the University;
- (p) The conditions under which students shall be admitted to the degree, diploma or other courses and to the examinations of the University and be eligible for the award of degrees, diplomas and certificates. The fees to be charged for admission to the examination, degrees, diplomas and certificates of the University;
- (q) The conditions of residence of the students of the University and the levying of fees for residence in hostels maintained by the University;
- (r) The fees to be charged for courses of study provided by the University;
- (s) The conditions and mode of appointment and the duties of examining bodies and examiners;
- (t) The conduct of examinations;
- (u) The conditions of service, remuneration and allowances, including traveling and daily allowances, to be paid to officers, teachers and other persons employed under the University; and
- (v) All other matters necessary for carrying out all or any of the purposes of the Act.

Statutes how
made

- 42 (1) The statutes with regard to matters set out in clauses (a) to (m) of section 41 shall be made by the Government at the first instance.
- (2) Subject to the prior approval of the Government, the Board may, from time to time, make any statute in addition to the statutes referred to in sub-section (1), and may amend or repeal any statute in the manner hereinafter provided in this section.

- (3) The Academic Council may propose to the Board, the draft of any statute to be made by the Board and such draft shall be considered by the Board at its next meeting:
Provided that the Academic Council shall not propose the draft of any such statute, any amendments of a statute or repeal of a statute affecting the statutes, powers or constitution of any existing authority until such Authority has been given an opportunity to express its views on such proposal and any views so expressed shall be considered by the Board.
- (4) The Board may consider any such draft as is referred to in sub-section (3) and make the statute or reject it or return it to the Academic Council for reconsideration, either in whole or part, together with any amendments which it may suggest.
- (5) Any member of the Board may propose to it the draft of any statute, any amendment of a statute or repeal of a statute and the Board may either accept or reject the proposal if it relates to a matter not falling within the purview of the Academic Council. In case such draft relates to a matter within the purview of the Academic Council, the Board shall refer to the Academic Council it for consideration, which may either report to the Board that it does not approve the proposal, which shall then be deemed to have been rejected by the Board, or forward such draft to the Board in such form as the Academic Council may approve, and the provisions of this section shall apply in the case of a draft so forwarded as they apply in the case of a draft proposed to the Board by the Academic Council.
- (6) Every statute made under sub-section (1) shall immediately after it is made, be laid before the "**Legislature**" of the State, if it is in session and if it is not in session, in the session immediately following, for a total period of fourteen days which may be comprised in one session or in two successive sessions, and if, before the expiration of the session in which it is so laid or the session immediately following, the "**Legislature**" agrees in making any modification in the statute or in the annulment of the statute, the statute shall thereafter have effect only in such modified form or shall stand annulled, as the case may be; so however that any such modification or annulment shall be without prejudice to the validity of anything previously done under the statute.

 - (5) The Academic Council shall not amend a draft of a regulation received from the Board of a Faculty but may approve or reject it or return it to the Board of Faculty for reconsideration either in whole or in part together with any amendment which it may suggest.

1 In the Andhra Pradesh Reorganisation Act, 2014(Act 6 of 2014) the Government of India notified Andhra Pradesh Reorganisation Act dated: 01.03.2014, and Government of India notified 2nd June, 2014 as appointed day for formation of a new State of Telangana.

2. The Veterinary Council of India, the apex body of Veterinary Education recommended to establish a Veterinary University in each State to foster Veterinary Education & Research. So far, thirteen States have established separate Veterinary Universities. There is a demand and imperative need for establishment of a separate Veterinary University in the State of Telangana.

3. Sri Venkateswara Veterinary University located at Tirupati, Chittoor district is covering colleges in States of Andhra Pradesh & Telangana. Since S.V. Veterinary University is not included in Schedule-10 of the Andhra Pradesh Reorganisation Act, 2014, Sri Venkateswara Veterinary University (SVVU), Tirupati has been instructed to complete all preparatory works of bifurcation activities as prescribed by Centre for Good Governance.

4. Accordingly, Sri Venkateswara Veterinary University (SVVU), Tirupati, has completed the tasks outlined by the Government of Andhra Pradesh vide Circular Memo No. 7164/SR/A1/2014 dated 12-3-2014.

5. The Board of Management, Sri Venkateswara Veterinary University in its 43rd Board Meeting held on 24.5.2014 has authorized the Vice-Chancellor to take all necessary action for bifurcation of the Sri Venkateswara Veterinary University and formation of New Veterinary University in Telangana State vide agenda No. 2.

6. Sri Venkateswara Veterinary University (SVVU) mandate involves Education, Research and Extension activities. Accordingly Veterinary Colleges, Research Stations and Extension Centres were established in both the successor States (erstwhile three regions) to address the location specific needs to meet above functions. At present, there are two Veterinary Colleges, one Dairy Technology College, Four Animal Husbandry Polytechnics, Two Livestock Research Stations, one Buffalo Research Station, one All India Coordinated Research Project on Poultry, one Krishi Vignana Kendra and One Fisheries Research Station functioning within the State of Telangana. It is clearly evident that the Sri Venkateswara Veterinary University (SVVU) possess the adequate number of Colleges, Research Stations and Extension Centres in both the successor State of Telangana and residuary State of Andhra Pradesh so that

undisrupted Teaching, Research & Extension Services are delivered to students and farming community in successor State of Telangana and Andhra Pradesh immediately after bifurcation of Sri Venkateswara Veterinary University (SVVU). However, since no Fisheries College & Polytechnic is located in Telangana State the Fisheries College, Muthukuru & Fisheries Polytechnic College, Bhavadevarpally may be treated as common facility as per article 371D to provide equal opportunities to students in both the States till a new Fishery Science & Technology College is established in Telangana State.

7. In G.O.Ms.No.178, General Administration (SR) Department, dated 18.5.2014 orders were issued in order to ensure equal opportunities for qualitative higher education to all the students in successor State of Telangana and residuary State of Andhra Pradesh for a period of 10-years following the existing admission quotas and admission process in the disciplines of agriculture, horticulture and veterinary with effect from the 2nd June, 2014. Hence, post bifurcation of Sri Venkateswara Veterinary University (SVVU) will not disrupt in providing equal opportunities in terms of admission quotas and process to students of both the States for quality higher education in Veterinary and Fisheries Sciences.

8. In circular Memo.No.13665/GA(SR)/2014, dt.26.05.2014 Government issued orders that all laws including an enactment, which were applicable to undivided State of Andhra Pradesh as on 01.06.2014, would continue to apply to the new State of Telangana and residuary State of Andhra Pradesh created by Central Act, 2014 with effect from 02.06.2014, notwithstanding the bifurcation of the erstwhile State of Andhra Pradesh. Accordingly the Act No. 18 of 2005 and Statutes of Sri Venkateswara Veterinary University of undivided Andhra Pradesh would be made applicable to the newly proposed operational entity of Veterinary University in Telangana State viz., P.V.NARSIMHA RAO Telangana State Veterinary University for smooth administration and to provide undisrupted Teaching, Research and Extension services post bifurcation.

9. Telangana State is blessed with rich livestock resources especially Cattle and Sheep population accounting to 5.52% of country's population. The State stands Tenth in total livestock population, 1st in sheep population, 12th in Goat population, 5th in Poultry, 13th in Bovine population and 17th in pig population, in the country as per the Livestock Census, 2007. The over all contribution of Livestock & Poultry sector to the Telangana State GDP is around 4.86% (2010-11 current prices). Though, State is having good livestock base but productivity levels are far below when compared to some advanced States such as Punjab, Haryana, Gujarat etc. Major improvements in livestock sector are possible only when Livestock Research and Veterinary Education is developed along with appropriate technologies and extension services.

10. Government after careful examination of the matter have decided to establish a new University for Veterinary Sciences in the State of Telangana in the name of "Sri P.V.Narsimha Rao Telangana State Veterinary University". The Nodal Officer / Director of Animal Husbandry, Telangana State, Hyderabad is hereby directed to take action on the following issues:- (1) Bifurcation of Sri Venkateswara Veterinary University, Tirupati and established under Sri Venkateswara Veterinary University Act, 2005 (Act, No.18/2005) and devolution of institutions to successor States based on their present location as per the Andhra Pradesh Re-organisation Act, 2014. Annexure-I. (2) To establish new Veterinary University in Telangana State to be named as 'Sri P.V. Narsimha Rao Telangana State University for Veterinary, Animal & Fisheries Sciences' post bifurcation and which is to be located at the existing campus at Rajendranagar, Hyderabad-500030.

11. Adaptation of existing Sri Venkateswara Veterinary University Act, 2005 (Act, No.18/2005) & Statutes of Sri Venkateswara Veterinary University, Tirupati during transitory period for smooth functioning of the University immediately post bifurcation as per circular memo No. 13665/GA(SR)/2014, dated: 26.5.2014 till enactment of Veterinary University Act.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 3 of Sri P.V. Narsimha Rao Telangana State University for Veterinary, Animal and Fishery Sciences Act, 2005 the State Government of Telangana hereby constitute Sri P.V. Narsimha Rao Telangana State University for Veterinary, Animal and Fishery Sciences with effect from **22.11.2014**.

2. The University shall be a body corporate having perpetual succession and a common seal and shall sue and be sued by the said name.
3. In all suits and other legal proceedings by or against the University, the pleadings shall be signed and verified by the Registrar and all processes in such suit and proceedings shall be issued to, and served on him.
4. The Head quarters of the University shall be in the existing campus at Rajendranagar, Hyderabad.
5. (1) The University shall consist of ,-
 - (A) The Chancellor: The Governor of Telangana shall be the Chancellor of the University;
 - (B) The Vice-Chancellor: To be appointed by the Chancellor.
 - (C). Board of Management.

The Board shall consist of the following members, namely:-

Ex-Officio Members

- (1) (a) the Vice-Chancellor;
 (b) the Secretary to Government, Animal Husbandry Department;
 (c) the Secretary to Government, Finance Department;
 (d) the Director of Animal Husbandry;
 (e) the Commissioner of Fisheries.

Other Members

- (f) one person to be nominated by the Chancellor from the members of the Indian Council of Agricultural Research;
 (g) one person who is in the opinion of the Chancellor a distinguished Veterinary/Fishery Scientist, nominated by the Chancellor;
 (h) three persons from the Academic Council to be nominated by the Chancellor;
 (i) four persons to be nominated by the Chancellor from among the members of the State Legislature and the Members of Parliament elected from the State of Telangana;
 (j) three persons nominated by the Chancellor from amongst the progressive farmers in Livestock, Poultry and Fishery sectors of whom one shall be a woman;
 (k) one person nominated by the Chancellor from amongst the members of the State Veterinary Council;
 (l) two persons nominated by the Chancellor from among the Industrialists in Livestock, Poultry and Fishery sectors.
 (2) The Vice-Chancellor shall be ex-officio Chairman of the Board, and shall conduct the meetings of the Board in accordance with the statutes made in that behalf.

The Academic Council:-
